

deeply cut.




Percentage of Pennsylvanians in each congressional district

The Republicans are proposing to cut Medicaid and SNAP to offset the cost of extending and expanding Trump's 2017 tax giveaway to corporations and the ultra-rich.

Half of the tax benefits would go to the richest 5%.

Voters in Pennsylvania want to raise taxes on the rich – not cut them.

Voters across Pennsylvania overwhelmingly want the rich to pay more in taxes and larger tax credits for working families.

Likely Voters in Pennsylvania Response	Topline
Profitable corporations are not paying enough in state taxes.....	76%
The wealthiest households are not paying enough in taxes.....	76%
Taxes should be increased for households earning more than \$400,000/year	77%
Child tax credits should be increased.....	72%
